Database and platform reports in JUSP

Database and platform reports were made live in JUSP at the beginning of September. For an up-to-date list of publishers and available reports please check this page: <http://jusp.jisc.ac.uk/participants/> - currently we have 21 providing PR1, 8 providing DB1, and 7 providing DB2.

We will continue to add further publishers (DB1, DB2 and PR1 reports) as they become available. We have approached a number of other database providers about joining JUSP and we have a wish list which you can use to make or support requests. Participating libraries can access this list by logging into JUSP and clicking on the Publisher issues / Wishlist tab and a public version of the list is available here: <http://jusp.jisc.ac.uk/participants/#link4>. We also encourage libraries to contact publishers directly to let them know why publisher participation in JUSP is important to them.

Webinars

The workshops will be run in summer and follow the same format as this year with an introductory workshop split into morning (journals) and afternoon (books and other reports) sessions, and then a separate workshop "update and exchange of experience" which will give attendees the opportunity to share ideas and practice as well as learn more about JUSP developments.
